

Q1 Do you recreate along the Truckee River?If yes, how long have you been recreating along the Truckee River?





Q3 If yes, how often do you recreate along the Truckee River?



Q4 If no, what are the reasons you don't recreate along the Truckee River?











Q12 Did you know that the Truckee River supplies 85% of the Truckee Meadows drinking water?







Q14 Do you know what non-point source pollution is?





Q15 Do you know ways to limit non-point source water pollution to the Truckee River?




